**USES:** BRIDGE-MATE™ is designed to protect and lubricate rocker arm/plate assemblies and protect caps of concrete bridge pilings. BRIDGE-MATE™ may also be used to seal the exterior of concrete or metal pilings that will be subterranean once installed. BRIDGE-MATE™ is superb at encapsulating and lubricating components on draw bridges, such as turn-tables, open gears, cables, and other movable components.

**SURFACE PREPARATION:** Always clean surface and neutralize existing salt, chlorides, grease and oil prior to application.

**METHOD OF APPLICATION:** Apply with RHOMAR'S 3-gallon Public Works Applicator.

**APPLICATION OF BRIDGE-MATE™:** Is ready to use, simply pour product into the applicator and apply to bridge surface needing protection. Once applied, BRIDGE-MATE™ cures into a polymer skin that will not wash off with rain or moisture. This prevents soil and stream contamination—a major environmental concern.

**COVERAGE OF BRIDGE-MATE™:** Approximately 200-300 square feet on metal surfaces and 100-200 square feet on concrete surfaces.
