**APPLICATION OF RHOMA-SOL™:** We recommend applying RHOMA-SOL™ with RHOMAR's 3-gallon Public Works Applicators or the convenient trigger spray bottles for small applications. When using RHOMA-SOL™ on painted finishes, always test for safety by spraying on an inconspicuous area first. Always rinse any dissolved residue from the cleaned surface with clear water rinse. Prevent spraying RHOMA-SOL™ on plastic parking light lenses as it may dull the finish.

**LIGHT ASPHALT OR OIL REMOVAL:** Simply spray a light coating of RHOMA-SOL™ onto asphalt/oil spills, splatters and oversprays and watch the deposits melt away. Rinse with hose or pressure washer.

**HEAVY ASPHALT REMOVAL:** Apply RHOMA-SOL™ liberally to deposits and allow 5 minutes to break the "glue molecule" that bonds asphalt and oils. Then repeat application and let set for 15-20 minutes and finally pressure wash the surface clean.
